1. Account name	<i>Savings Bank account / Call Deposit</i>
What is the interest rate?	Interest on the credit balances will be calculated at the rate of 1.00% for GBP deposits and 1.00 % for USD deposits and paid on half yearly basis (March 31st & Sep. 30th) on daily clear balances for Call Deposits.
	Interest on the credit balances will be calculated at the rate of 1.90% for GBP deposits and 1.90 % for USD deposits and paid on half yearly basis (March 31st & Sep. 30th) on daily clear balances for Savings Bank Deposits.
Can BANK OF INDIA change the interest rate?	Yes, Bank of India has the right to change the rate or rates of interest. Whenever there is change in the market interest rates, base rates, cost of funds for the bank, Net Interest Margin and lending rates, Bank of India reserves the right to change the rate of interest. The notice of change will be given at least 5 working days before the change of interest rate.
What would the estimated balance be after 6 months based on a £ 1000 deposit?	<u>Illustration (savings account):</u> If £ 1000 is placed in Call Deposit account on 01.04.2024, the interest payable @1.00 % per annum on 30.09.2024 (after 6 months) will be £5.00. If £ 1000 is placed in Savings Bank account on 01.04.2024, the interest payable @1.90 % per annum on 30.09.2024 (after 6 months) will be £9.50.
How do I open and manage my account?	1. Savings Bank Account: Eligibility Savings account/s can be opened by individuals or jointly with other individuals. Minimum balance and Maximum balance For UK depositors: GBP 250.00 or the equivalent in other currencies is the minimum balance. For non-UK depositors: GBP 2500.00 or the equivalent in other currencies is the minimum balance. The account holder/s is required to maintain the above minimum balance in the account at all times. We have the right to apply a charge for not maintaining such minimum balances as required. The present charges for not maintaining the minimum balance in the Savings Bank account is GBP 1 per month for UK depositors & GBP 2 per month for

What would the estimated balance be after 1 year based on a £ 1000 deposit?	<p>Illustration:</p> <p>If £ 1000 is placed in Fixed Deposit on 01.09.2025 for one year period, the interest payable @ 4.15% AER on 30.08.2026 will be £41.50 and the maturity amount will be £1041.50.</p> <p>If \$ 1000 is placed in Fixed Deposit on 01.09.2025 for one year period, the interest payable @ 4.10% AER on 30.08.2026 will be \$41.50 and the maturity amount will be \$1041.00.</p>																																			
How do I open and manage my account?	<p>Minimum / Maximum amount</p> <p>Individuals – GBP 1000.00 or equivalent in other currencies</p> <p>Others like Corporates and Trusts - GBP 10,000.00 or equivalent in other currencies</p> <p>There is no maximum amount restriction, but it is subject to submission of source of funds / source of wealth proof for the funds deposited.</p> <p>Withdrawal</p> <p>The Fixed Deposit account is a non - withdrawal account. All transactions to and from this account will be through a Call, Current or Savings Account, which must be opened by you when placing funds in the Fixed Deposit Account, if such an Account is not already opened.</p> <p>Deposit Period</p> <p>Minimum period of deposit is 7 days and the maximum is 60 months (5 years). Withdrawals before the maturity date - Premature withdrawals are permitted. No interest will be paid on deposits withdrawn within 30 days of account opening. Where withdrawals are made after 30 days, but before the maturity date, the</p>																																			

interest payable will be **0.1% less than the applicable interest rate for the actual period it has run / completed at the time of breaking/ payment.**

Illustration: If the deposit of £ 1000 is placed for 1 year at the interest rate of 4.15% AER but the customer requests premature payment after 7 months, the applicable interest rate will be the current / existing interest rate for 7 months at the time of breaking less penalty of 0.1% i.e. $4.05 - 0.10 = 3.95\%$. If in the same case, the breaking happens after 5 months, the current interest rate for 5 months less penalty of 0.1% is the applicable interest rate i.e. $3.00 - 0.10 = 2.90\%$.

If the deposit of \$ 1000 is placed for 1 year at the interest rate of 4.10% AER but the customer requests premature payment after 7 months, the applicable interest rate will be the current / existing interest rate for 7 months at the time of breaking less penalty of 0.1% i.e. $3.50 - 0.10 = 3.40\%$. If in the same case, the breaking happens after 5 months, the current interest rate for 5 months less penalty of 0.1% is the applicable interest rate i.e. $3.25 - 0.10 = 3.15\%$.

Prior notice of two working days will be required for withdrawals before the maturity date.

Fixed Deposit Receipt

A deposit confirmation advice will be mailed to you after your Fixed Deposit Account has been opened.

COMMUNICATION CHANNELS:

The customer can communicate / transact at his / her bank account by personal visit, letters by post or by logging into the Internet banking facility if already availed from the bank, for the Retail customer. If the customer likes to contact the bank by Fax, e-mail, Telex, he /she is required to execute an applicable Indemnity form available at the branch for the purpose.

Tax treatment

As per the existing HMRC guidelines on Income Tax, UK banks are not required to deduct income tax on the interest paid on bank deposits. In case of US citizens / residents, the customer has to declare the USA Social Security No. and may be subject to payment of tax on principal and interest amount if the bank is advised so by US Treasury under FATCA requirements.

Auto-Renewal/ Roll over of deposits

The maturity proceeds (Principal + Interest) will be rolled over for the original deposit period if there is no renewal or payment instructions received from the customer **before the maturity date.**

The customer agrees to the Auto rollover of Fixed deposit on the maturity date (if no contrary instructions are given by him /her) by signing this Summary box sheet shared with him / her. If the auto roll over option is not preferred, the customer may select the option of sending renewal/ payment instructions before the maturity. If opted for option 2, but no such instructions are received by the bank before the maturity date, the bank reserves the right to roll over the fixed deposit for the same maturity period to protect customer's interest by the way of ensuring interest accrual till the actual payment date.
